## **RIPARIAN RESTORATION UPDATE:**

Bank erosion has been a concern in Quiet Water for a number of years. The board is still trying to find some workable solutions, but there are no easy answers. In mid-November, Jim Welch arranged for a site visit of the Mid-Coast Watershed Council (MCWC) and Lincoln County Soil Conservation (LCSC). In addition to Jim, board member Nan Scott, DRC chairman Loren Dickinson, and homeowners Linda Redmond, Steve Kriegh, and

Rebecca Owen participated in the walk-through.

Here are some salient points from the visit:

- With proper permitting, trees that are in the riparian zone may be removed if they pose a <u>safety</u> hazard. Appropriate trees and shrubs should be planted to replace them.
- Older alders could be thinned, but some trunks should be left standing as habitat and to continue to stabilize the bank. Shade tolerant conifers should be planted to replace the canopy – important for

keeping the river cool in summer for fish habitat.

- Willows are recommended for revegetation in areas where the bank has eroded. Evan could make available plants and cuttings and volunteers to join QW to organize a planting day.
- Quiet Water volunteers should continue to remove ivy, blackberry and other invasive weeds.
- Tyler will contact QW about a herbicide application program for knotweed and other hard to remove invasives next summer.
- Regarding the east-west run of the river, Tyler thought that we can use the existing guard log structures along the bank to plant willow and other species for bank stabilization.

This simpler, less engineered approach may save us money and be more doable than the proposal that was approved at the annual meeting last year, but it will require QW volunteer participation.

Jim Welch who has been charged by the DRC (Design Review Committee) to monitor our riparian area, has been in conversation with City Planner, Katherine Guenther, regarding permitting issues for bank stabilization. The jury is still out as to whether cutting older trees BEFORE they fall into the river is permissible or advisable. We will keep you posted.
