Rain, River, Wind and Waves

The elements combined to put on quite a show in Quiet Water and Yachats in mid January. Heavy rainfall during the month pushed the monthly total anywhere from 12" to 17" according to readings from several locations in town. Soils became saturated and the Yachats river rose to just below flood stage. High winds from a January storm interacted with King Tides on January 11-13 to create high water in LCA I and the recreation area (tennis courts, playground, and pool).



Waves coming up the Yachats River pounded their way into sloughs, and incursions along the bank leaving debris in their wake and tugging at the bank as they receded.

So what are King Tides and why is it important to pay attention. A King Tide is a non-scientific term people often use to describe exceptionally high tides. Higher than



normal tides typically occur during a new or full moon and when the moon, sun, and earth align and the moon is closest to the earth in its orbit. The highest tides here usually occur in the summer and winter. Because our summers are usually fairly dry, we are more likely to see coastal flooding during the winter King Tides.

King Tides are important, because scientists tell us that they preview how sea level rise will affect coastal places. As time goes by, the water level reached now during a

Although there will be cleanup to do, fortunately there was no serious damage.

There are measures we can take to mitigate the damage such as not cutting paths down to the river which gives waves an opening to exploit. Robust plants with strong root systems can help protect the river bank from tidal activity. The board will be exploring with local authorities other measures we might use.

Quiet Water residents Wally Orchard and Jim Welch could be called the "Birdmen of Quiet Water". Over the years they have built and placed several bird boxes around Quiet Water for the enjoyment of birds and residents alike. They have had particular success with chickadees, violet-green swallows, and tree swallows.

Now they are on a mission to build a "swallow trail" of 100 boxes over the next two years to be placed around Yachats and up river. The board has approved six for Quiet Water.

Tree swallows and violet-green swallows have similar nesting habits that are different from barn swallows that nest on porches and under eves of houses creating a nuisance. The birdboxes will attract a much better behaved neighbor.

Jim and Wally have also installed a box suitable for owls and plan to build and install another large box on the river, suitable for wood ducks and mergansers, both of which have been seen locally.

Board Business

The QW board had its 3rd meeting of the fiscal year on February 7th via Zoom. Minutes are still in draft form, but a summary of the meeting follows.

All Board members were in attendance in addition to DRC chair, Loren Dickinson, and members Wally Orchard, Linda Tweto-Johnson, Ginny Hafner, Hayden and Shana Chandler.

Rebecca and Nan will meet in the coming weeks to create a preliminary budget for 21-22 for board approval prior to presenting to the annual meeting in June. Packets will come out in May, but we are waiting to see if the annual meeting will be in person or by Zoom.

Loren has secured willow cuttings which will be planted to conserve and protect the riparian area. Although this willow species is "robust", Rebecca received conformation from the State that they can be pruned as long as the plant remains viable after pruning. SEE PAGE 6 (yellow box) FOR CITY RESTRICTIONS. Location for these starts and planting dates will soon follow. Volunteers will be needed, so stay tuned.

The pool enclosure has suffered some damage. Window sills and slats below the windows require replacements. Bob will get bids. Mold in the men's bathroom and perhaps elsewhere must be eliminated. Rebecca is in conversation with a company to do the work. The board

agreed to purchase a new cover for the spa pool. We have not been successful in securing a pool manager so we will hire Emerald Pool and Patio to visit and provide recommendations for upkeep during the off season.

Grounds: Site Manager, Tom Lynch makes weekly curbside pickups but his schedule cannot be pinned to a specific day. Tom is scheduling around the demands of two other part time jobs. Residents can help by making sure that debris is removed from street drains. Playground chips washed away in recent storms will be replaced later this spring. Rebecca will contact Tom Lynch Sr. concerning trimming of a big tree between Redmon and Brice properties. The tractor may be replaced in the next budget cycle.

Boat Storage – There is only one launching site for water craft near the point where the river bends. Any other boat access to the river is in violation of HOA rules. The board is contemplating ideas for boat storage near the launch site and proposed a temporary solution for the Wybenga paddle boat.

A request for community food scrap composting was denied. Jim Welch and Wally Orchard were given permission to locate 6 swallow boxes in Quiet Water. Nan Scott will develop a survey to assess path options so that a plan of action can be proposed at the annual meeting..


