Got Renters?

From time to time I get to hear complaints over the behavior of renters in Quiet Water, so it is perhaps just as well to send out a note about some of the issues that crop up.

Sometimes a big group of renters will be in a rather small space, like a cottage in LCA III. These groups often get pretty noisy and disturb the peace and quiet for their neighbors. They may also take up so many parking spots that other residents need to park out on the street. Renters should be informed that each LCA cottage is entitled to no more than two marked parking bays. Dogs can also be a nuisance, whether running around off-leash or just barking incessantly. Please also note the following extract from our C C & R's:

- 1.5 No trailer, mobile home, modular home, factory-built dwelling, pre-fabricated house, motor home, camper-truck, tent, garage, barn, shack, or other out-building shall at any time be used as a residence temporarily or permanently on any part of said property.
- 1.6 Parking of boats, trailers, motorcycles, trucks, truck campers and like equipment, shall not be allowed on any part of said property nor on public ways adjacent thereto excepting only within the confines of an enclosed garage. All other parking of equipment shall be prohibited except as approved in writing by the Design Review Committee. No junk cars or unsightly vehicles are allowed on the property.

If you rent out your property, please make sure that renters are always made aware of these issues. And if you rent through an agency, the agent should ensure that the renters are informed.
